The uniform is worn with pride. It is a way to demonstrate that students have made to join the DPS community. It is a symbol of pride and their commitment to fully embrace the values and spirit at our school. Our policy is that all children should wear clothing that is in keeping with a purposeful learning ethos. We also believe that certain school activities are facilitated by specialized and appropriate clothing (including organized events outside normal school hours). There is an expectation that students will comply with the dress requirements and that valuable school time will not need to be diverted to following up on breaches of school uniform policy.

Uniform is compulsory during school hours and for all school functions, including all instances where the students represent the school outside . it must be neat and clean every day .

<u>AIM</u>

Our policy is based on the belief that a school uniform:

- ✓ promotes a sense of pride in the school
- ✓ engenders a feeling of belonging
- ✓ is practical and distinctive
- ✓ identifies the children with the school
- ✓ is not distracting in class (as fashion clothing might be)
- ✓ makes children feel equal to one another in terms of appearance
- ✓ reflects the sense both of community and of diversity that the school takes pride in
- ✓ is regarded as suitable, and good value for money, by most parents

SCHOOL UNIFORM POLICY

- ✓ Pants or shorts must be worn with a belt at the waist and belts must be through the loops. Pants can be cotton, cotton blend. Absolutely NO cargo pants, jeans, sweat suit pants, pajamas, logos, insignias, pictures or messages. Shorts must be knee length or longer.
- ✓ Skirts must be knee level or longer. Can be cotton, cotton blend
- ✓ Shirts must be tucked into pants. Absolutely NO logos, insignias, pictures or messages.
- ✓ Only School sweater with logo to be worn.
- ✓ Shoes must fit securely on the foot. No shoes with open toes or backless shoes (including flip flops, sandals, mules and slides). Shoes must be laced or buckled. No heels or rollers.
- ✓ NO OVERSIZED CLOTHING WILL BE ALLOWED. NO TIGHT FIT CLOTHING WILL BE
 ALLOWED.
- ✓ No colored wrist bands, neck beads, head bands are allowed.
- ✓ Hair longer than shoulder length to be plaited for girls or tied neatly. For short hair, black hairbands/black . IT IS AGAINST THE SCHOOL POLICY TO COLOUR THE HAIR.
- ✓ Rubberbands to be worn. For boys, hair should be trimmed neatly.
- ✓ Nails to be trimmed and no nail polish allowed.
- ✓ Streaking and coloring of hair is not permitted.
- ✓ No make-up, flashy jewelry and body adornments must be worn. Earrings should be kept to studs.
- ✓ In case of defaulters, student will be warned first. Repeated defaulter, will not be allowed to attend classes. Parents will be asked to bring the uniform / or the students wears the uniform which he /she will purchase from the store.

HEALTH AND SAFETY

Students will be issued with a Health and Safety policy in the Science departments. This may include appropriate closed footwear, protective clothing/coat, safety goggles etc. If students do not wear the appropriate uniform for a lab work, they will not be allowed to enter the lab.
